 - SEOI shall not be construed as a commitment on the part of TCO, nor shall it entitle any supplier to make any claims whatsoever, and/or seek any indemnity from TCO and/or any of its Partners, by virtue of such supplier expressing its interest
 - All expenses incurred in preparing and maintaining SEOI shall be borne solely by the supplier
 - TCO reserves the right to reject any SEOI Web Form and deactivate SEOI Supplier Profile for reasons solely within TCO discretion
 - It is important to keep SEOI Username, password and e-mail address in a secure place
 - SEOI shall be submitted by a Supplier Authorized Representative

If User's assigned User Name(s) and granted access are intended for SEOI, the following also applies:

- 11.1User's Agreement. In consideration of the opportunity to express interest to do business with TCO within the Tengizchevroil System, User, by clicking "I accept all terms and conditions", agrees to the following terms and conditions with Tengizchevroil LLP ("TCO"):
 - (i) Supplier Expression of Interest (hereinafter "SEOI"). Prior to submitting supplier's expression of interest to which it has been given access by Tengizchevroil, User has received, read, understood and agrees to the terms and conditions.
 - (ii) SEOI Web Form. User acknowledges that any SEOI Web Form it submits through SEOI web tool within the TCO external website is legally valid and binding on User. User agrees that any SEOI Web Form it submits through SEOI web tool within the TCO external website is firm until accepted or rejected by Tengizchevroil. User agrees that it will only submit SEOI Web Form and/or any changes to the Web Form through SEOI web tool within the TCO external website and will not submit SEOI Web Form and/or any changes to the Web Form to Tengizchevroil via any other mechanism, unless requested to do so in writing by Tengizchevroil. User understands Tengizchevroil has the absolute right, in its discretion, to accept submitted SEOI Web Form or not to accept SEOI Web Form, or to cancel or postpone any SEOI Web Form submission, at any time with or without cause or notice.
 - (iii) Data Privacy Notice. Prior to submitting supplier's expression of interest to which it has been given access by Tengizchevroil, User has received, read, understood and agrees to process personal data to be used by a TCO authorized official for the purpose of acceptance of the submitted SEOI Web Form by User. Be aware that submitted personal data will be sent to appropriate departments within TCO with the purpose of verifying supplier's capabilities. To review and correct the submitted personal data, please contact TCO SEOI team. User may not provide personal data; in such case TCO reserves the right to reject User's SEOI Web Form.
 - (iv) General. The requirements for any submitted SEOI Web Forms are detailed in the enclosed SEOI Instructions document. Should User decide to submit SEOI Web Form, all costs associated with the submission of SEOI Web Form and/or changes to it (including all costs relating to document preparation) shall always be for User own account without any claim upon TCO. TCO reserves the right to add, delete, modify or amend any part of the SEOI web tool and SEOI Web Form, with all such changes being transmitted to Users, when needed. TCO shall also have the right to decide not to accept SEOI Web Form submitted by User(s) and/or reject any and all SEOI Web Forms for any reason whatsoever, without stating any reason and with no further obligation whatsoever on the part of TCO.
